

Types of Residency Options

Precarious Residency

Allows you to live in Argentina while applying for a permanent residency type. Grants the right to work and study, lasting for 90 days. Can be renewed until final residency is granted.

Transitory Residency

Granted for a maximum of one year. Does not allow for obtaining a National ID (DNI).

Temporary Residency

Granted for up to three years, depending on the type applied for. Allows obtaining a temporary DNI.

Permanent Residency

Has no expiration date. Allows obtaining a permanent DNI.

Required Documentation



Valid Passport

Current passport to prove identity.



Criminal Background Checks

Argentine check issued by the National Registry of Recidivism (for those over 16) and certificates from countries where you've resided for more than 1 year in the past 3 years.



Proof of Address

Documentation verifying your residence in Argentina.



LegalEntry

Evidence of legal entry into Argentina.

Entry Permit to Argentina

What is it?

The Entry Permit is a prerequisite for residency applications for certain foreign nationals. It is issued by the National Directorate of Migration (DNM) and authorizes legalentry to Argentina for residency purposes.


Who must apply?

- Foreign nationals intending to live legally in Argentina
- Those outside the country seeking temporary or permanent residency
- Non-MERCOSUR citizens (and some MERCOSUR citizens depending on the case)

Process Overview

The DNM issues an Entry Permit that must be presented at the Argentine consulate in the applicant's country to obtain the corresponding visa. Once the visa is issued and the applicant enters Argentina, they are automatically considered residents and must apply for a DNI within 60 business days.

Types of Entry Permits



Permanent permits are available for spouses, parents, or children of Argentine citizens (native, naturalized, or by option) and for spouses, parents, or unmarried children under 18 (or adults with disabilities) of permanent residents.

Temporary permits serve various professionals and specialized workers, while transitory permits accommodate shorter-term stays for specific purposes.



General Requirements for Entry Permit

Application Form (FLE)

Complete the Residency Form online via the RADEX system, including personal details, reason for application, and sponsor information if applicable.

Applicant's Documentation

Submit passport copy, birth certificate (legalized/apostilled and translated if not in Spanish), and criminal background checks from countries of residence for the past 3 years.


Reason for Application

Provide documentation supporting your migration category: family certificates, work contracts, educational admission letters, religious mission confirmation, or business investment documents.

Where is it Processed?

RADEX System

Submit application through the online portal at https://radex.migraciones.gob.ar



Sponsor Assistance

Sponsors in Argentina may help initiate the process

ApprovalCode

Receive processing code for consular visa application

Processing Time

30-90 days depending on case complexity

Applicants must remain in their home country while waiting for approval. The estimated processing time varies based on the complexity of each case and the completeness of submitted documentation.



What Happens After Obtaining the Permit?



Receive Approval

Get processing code



Visit Consulate

Present code and documents



Obtain Visa

Receive entry visa



Enter Argentina

Complete residency steps

Once your Entry Permit is approved, you'll need to visit the Argentine consulate in your country with the processing code. After fulfilling the consular requirements, you'll receive a visa that allows you to legally enter Argentina and begin the final steps of your residency process.

Consular Process



Document Submission

Visit the consulate with your approval code and fulfill all requirements for visa processing.



Biometric Collection

Provide your photo, signature, and any other biometric data required by the consulate.



Visa Issuance

After paying any required fees, receive your official visa that will allow you to legally enter Argentina as a resident.

The consular process is the final step before traveling to Argentina. Once you have your visa, you'll be able to enter the country with resident status and will need to complete the process by obtaining your DNI within 60 business days of arrival.
